## Taking EF Fund-Raising in Stride Chapters Step-Up Support For Design Education

Stepping out smartly in support of design education, 13 chapters raised a total of \$29,000, netting \$18,400 for grants and scholarships awarded by the IFDA Educational Foundation.

The 2010 Walk for Design Education project was supported by local businesses and by national partners that are bold-face names in the industry: Benjamin Moore, 3M, Hunter Douglas, Wood-Mode Cabinetry, E.J. Victor, Market Square at Highpoint and The International Home Furnishings Center, High Point, NC.

The chapters stepped out in creative style, reports the delighted EF Walk Chair Wilma Hammett. For example, the fundraiser was a walk in the park, literally, for **New York Chapter** members and friends, who strode the High Line Park, built on an abandoned railroad line above the City's West Side.

Members of the **Texas Chapter** brought their dogs along on the historic Campion Trails beside the Trinity River in Dallas. **Philadelphia Chapter** members ambled past masterpieces in the *Picasso and the Avant-Garde* show at the Philadelphia Museum of Art. The **Carolinas Chapter**

participants strolled the streets around the High Point furniture market and visited the landmark building shaped like a giant chest with a pair of socks hanging out of one drawer in reference to the city's furniture and hosiery industries.

**New England** and **Minnesota** covered their respective cities' design centers and **Northern California** staged a wine tasting and book-signing with Nancy Castelli, author of *Get Organized Today*.

As the philanthropic arm of the IFDA, the Educational Foundation offers the most scholarships and grants of any organization in the furnishings industry. More than a dozen awards that total over \$30,000 help to support design

students, interior design programs, and professionals who want to broaden their education. In addition EF grants help restore America's historic sites, such as Eleanor Roosevelt's Val-Kill Cottage in Hyde Park, NY, and the Lee-Fendall House in Alexandria, VA.

"The Walks have made it possible for EF to increase the amounts of our scholarships and grants," Wilma Hammett, FIFDA, Walk chairperson reports. "That's especially important today when student's needs are greater than ever in this tough economy."

## In Memoriam: FIFDA Sharon Clancy Lienau

Cancer claimed the life of FIFDA Sharon Clancy Lienau at age 67, just eight months after her husband Hank Lienau's brave and prayerful battle with cancer ended.

Sharon and Hank, her husband of 34 years, moved to Bluffton, SC from Chicago in 2008. Shortly after their move, Sharon received a life-saving organ transplant. Since her "second chance at life," both she and her husband

were active in promoting organ donor awareness and Donate Life marketing and media activities. Sharon herself is now an organ donor.

A native New Yorker, Sharon spent her entire professional career in the practice of public relations. A Rosemont College graduate Sharon certified at Radcliffe College Graduate School of Business before joining the J. Walter Thompson Company in New York where she worked for over 10 years in corporate and product publicity executive capacities. She later became Director of Public Information for a Union Carbide company, before realizing her flair and passion for home furnishings and design.

She worked for Hayes Williams Public Relations in New York, then the nation's

largest home furnishings PR agency. When her husband transferred from New York to Chicago in 1981, she continued to represent that agency in the Midwest. Later she formed her own public relations agency specializing in furnishings and design. Her accounts ranged from architects to art galleries, interior designers to furniture and fabric manufacturers.

Sharon was a Fellow of the International Furnishings & Design Association (IFDA). She served on its boards in the New York and Illinois Chapters, was its International Director of Marketing, and in 1997 was elected International President of the Association during its Golden Anniversary year. The following year she received the highest honor ever awarded to an IFDA member, the Honorary Recognition Award which afforded her lifetime membership in the association. She often reported that her most rewarding achievements in her career were in having assisted in the design, refurbishing and decorating of more than 60 Ronald McDonald Houses throughout the country, where her husband was a founding director and national coordinator.

In addition to heading up alumnae activities for Rosemont College in the New York and Chicago Chapters, she also was active in designing and donating furnishing for several women's shelters in the Chicago area.

She is survived by a brother John G. Clancy of Tequesta, FL., two step children, Mark W. Lienau of Canaan, VT, Jane Lienau Rowe of Bowdoinham, ME, five grandchildren, several godchildren, and dozens of loving cousins, nieces, nephews, great nieces, great nephews, and caring, wonderful friends.

A funeral mass was celebrated on January 29th at St. Gregory the Great Catholic Church in Bluffton, where she and her late husband were members. Lambeth and the upholstery from his new collection for Vervain. Barry also directed the placement of all the art on all the walls.

Included in the tour of the Avery's home/gallery was a "guided tour" of the gallery room in the penthouse and a detailed explanation of her custom framing business which includes special finishes ranging from very contemporary burled wood to extremely ornate, handcarved gold- and silver-leaf reproductions of European antiques. "We employ some very talented artists" Mrs. Avery commented understatedly about the craftsmen she hires to execute the custom designs and special orders. As a courtesy to the designers attending the event, those who wished to do so were able to purchase from her collection that evening.
